
I encourage our members to volunteer with one or more of our programs, and invite your friends and family to support OCA-NJ. Join in on the upcoming events.

## Virginia Lou Ng

## August 11, 1951 ~ May 18, 2022

**B**orn in Winston-Salem, North Carolina, Virginia and her family moved to New York City in the 1960s seeking better access to higher education. Always creatively inclined, she attended the High School of Art and Design as well as the School of Visual Arts. She met her husband John in 1974 and they were married in New York City's Transfiguration Church. Their first son, Jonas was born a year later, so they moved to Bloomfield, NJ to allow for their growing family. Maxwell was born two years after that.

After owning her own small card and gift shop, Virginia answered a call to service in 1986 and went to work for the Girl Scouts of Essex (NJ) as a Field Manager. Following a relocation, she took a new position with the Girl Scouts of Bergen County (NJ); there, she made strong friendships, embraced the nonprofit world of youth leadership and empowerment, and discovered her talent for fundraising.

Her work with the Girl Scouts introduced her to her great passion advocacy work, and she was nominated to serve as Commissioner for the Bergen County Human Rights Commission. Through this work, she also became a passionate advocate on behalf of Asian Americans. She would go on to twice serve as President of the Organization of Chinese Americans New Jersey Chapter (OCA-NJ). With OCA-NJ, she created several programs to assist AAPI youth: an internship program in the New Jersey State Legislature; a scholarship fund to assist with the increasing costs of college expenses; and a career fair to help seed Asian American leadership. Through all of this, she also created the fundraising support to sustain these programs, inaugurating various black-tie fundraisers and pushing to increase chapter membership. She organized and chaired the OCA National Convention that was hosted by OCA-NJ in Jersey City in 2016. Her interactions at the state level were noticed at the federal level, and she would go on to serve OCA as the National VP of Finance and the National VP of Chapter Development.

Her service to others extended beyond her advocacy work and continued with personal endeavors as well. She was the leader of five different Girl Scout troop, of which 18 girls would go on to earn their Gold Award, the highest youth award in Girl Scouting. She herself would be awarded the Thanks Badge, the highest honor for an adult volunteer. A hobby that started during the time she owned her card shop, she would often prepare wedding stationery for friends and family with decorative calligraphy. As the proud parent of a trans son,



she began to advocate for LGBTQ+ rights, speaking to other parents struggling with their children coming out. The entire Ng family would receive the National Queer Asian Pacific-Islander Alliance (NQUAPIA) Community Catalyst Award in part because of this work. After retiring from the Girl Scouts, Virginia would continue to tap her skills and talents to fundraise for the Charles B. Wang Community Health Center so underserved Asian Americans communities would have access to high quality, affordable healthcare. She also volunteered with AARP and was awarded the Andrus Award for Community Service.

Virginia devoted herself to family, a group that she defined without limitation. She was beloved and will be dearly missed. If you would like to honor her and the connections you made because of her, our family encourages you to donate to the OCA scholarship fund named in her honor — the OCA-NJ Virginia L. # Vincent Chin 40th Remembrance & Rededication

June 16th - 19th Vincent Chin was a 27 year old Chinese American attending a night out on the town for his bachelor party in Detroit on June 19, 1982 to celebrate his upcoming wedding. That night, he was brutally beaten by two white men, with a baseball bat at a time of intense anti-Asian hate.



## Nai-Ni Chen, Artist Extraordinaire of Traditional and Contemporary Dance

Nai-Ni Chen (1959-2021) a long time supporter of OCA-NJ Chapter, was the founder, choreographer and artistic director of the Nai-Ni Chen Dance Company. She was an artist recognized by the community not only as a tradition bearer but also an extraordinary artist dedicated to bridge the traditional and contemporary artistic worlds and empowering future generations. In NYC, she studied with Doris Rudko, Bertram Ross, Ellen Tittler and Mary Anthony. In her 36 years career, she has received numerous national and international awards, including the prestigious Choreography Fellowship from The National Endowment for the Arts. She has created more than 90 original works, toured in 47 states and around the world represented by Joanne Rile and Red Shell Artist Management. Along with creating dances for her own company, she choreographed for New Jersey Ballet,

Dancing Wheels Company, and BalletMet in Ohio. The Nai-Ni Chen Dance Company, managed by Andy Chiang, continues to present Nai-Ni's work and advancing her vision towards an equitable and diverse world of dance — <u>www.nainichen.org</u>

This past May at the NJ Performing Arts Center in Newark, a celebratory special performance was held of her incredible legacy of dancer, choreographer, culture ambassador, and educator. In addition, a vibrant dance concert with guest artist the Ahn Trio to standing ovation was performed commemorating the Year of the Water Tiger. 

Theresa Chan, registered nurse and OCA-NJ Chapter Board Member, shared this research article that focused on the specific needs of Asian Americans (AA) and examined the prevalence of HRSN during a period spanning the COVID-19 pandemic to inform strategies to improve cancer screening and primary care among AA patients. We hope that sharing this article raises awareness of the HRSN in our AA communities and think about how we each can help our Asian American family and friends in need.

## K-12 Asian American, Native Hawaiian and Pacific Islander **Volunteer Opportunities Curriculum Project**

OCA Asian Pacific American Advocates is leading a push for our nation's schools to teach Asian American, Native Hawaiian and Pacific Islander history.

OCA's Policy Platform on education "is that our public and private education systems must see equitable access as well as AAPI representation in curriculum. It is believed that education is the great equalizer and the primary support for American social and economic mobility. To fulfill this promise however, education must be equal and fairly represented across all communities.

OCA is committed to the fair representation of Asian Americans, Native Hawaiians, and Pacific

Islanders (AANHPI) in K-12 curriculum to ensure that it reflects the diversity of the American experience and accurately portray AANHPI history. Not only does AANHPI history help to create a more inclusive and comprehensive understanding of American history, but it also helps fight anti-Asian racism and xenophobia."

The K-12 AANHPI Curriculum Task Force advocates for the inclusion of AAHPI curriculum in our nation's classrooms. This Task Force will create a national database of AANHPI curriculum that is diverse, equitable, and inclusive in its treatment of AAN-HPI history. In January 2022, New Jersey's Governor Phil Murphy signed legislation that will ensure that the contributions, history, and heritage of Asian Americans and Pacific Islanders (AAPI) are included in the New Jersey Student Learning Standards for Social Studies for students in kindergarten through Grade 12. The legislation will create an AAPI curriculum requirement for schools and will establish the Commission for Asian American Heritage within the Department of Education. New Jersey was the second state after Illinois to require this curriculum, and more states are starting pushes to require AANHPI curricula. The New Jersey requirement is expected to take effect with the 2022-2023 school year. **OCA**
